



## **Behaviour-Based Safety (BBS)**

Behaviour-Based Safety (BBS) is a proactive approach to workplace safety that focuses on identifying and modifying at-risk behaviours to prevent accidents and injuries. Unlike traditional safety programs that emphasize rules and compliance, BBS involves employees in the process of observing, analyzing, and reinforcing safe behaviours.

The core principle of **BBS** is that most workplace incidents result from unsafe behaviours rather than equipment failures or environmental factors. By encouraging safe work habits through positive reinforcement, feedback, and employee engagement, organizations can create a stronger safety culture and reduce workplace injuries.

#### **Key Component of Behaviour Based Safety:**

#### 1.Observation and Feedback

- \* Employees and supervisors regularly observe workplace behaviours to identify safe and unsafe behaviours.
- ❖ Constructive feedback is provided to reinforce safe practices and correct risky behaviours.
- Observations should be non-punitive to encourage honest reporting.

#### 2.Employee Involvement

- ❖ Workers participate in safety committees, peer observations, and safety discussions.
- Involving employees increases ownership and accountability for safety.
- Frontline workers often provide the best insights into real-world hazards.

#### 3.Data Collection and Analysis

- ❖ Safety observations are recorded and analyzed to identify trends.
- ❖ Data helps prioritize areas needing improvement and measure the effectiveness of interventions.
- ❖ Common metrics include near-miss reports, unsafe act frequencies, and compliance rates.

#### 4. Positive Reinforcement

- ❖ Safe behaviours are recognized and rewarded (e.g., verbal praise, SOS/ SWA incentives, or awards).
- ❖ Positive reinforcement encourages repetition of desired behaviours.
- ❖ Avoid over-reliance on punishment, which can discourage reporting.

#### 5. Training & Education


- \* Employees receive training on safe work practices and the principles of

- Continuous learning ensures that safety remains a priority.

#### **6.Continous Improvement**

- Safety programs should evolve based on feedback and incident trends.
- Regular reviews and updates ensure that BBS remains effective.
- Encouraging open communication helps identify new risks and solutions.

#### What is the ABC model in behaviour-based safety?

The ABC model(Antecedent behaviour Consequence) model is the well-established and scientific approach to analyze why people act in a certain way and find ways to implement behavioural changes. The A stands for antecedent, which is the prevailing condition that works as a catalyst for the preceding action. Antecedents reveal what set off the behaviour.

The B stands for behaviour, which is defined as the visible action that a person performs which is observable and measurable.

The C stands for consequence; it is the action that takes place after the outcome of the behaviour is triggered. It could either be positive or negative depending on the result of the behaviour.

Feedback, dramatically improves, Safety behaviour. At the same time, reduces injury frequency
